6) RIDER, TECHNICAL, BACKLINE REQUIREMENTS

If catering is not available, the promoter agrees to pay for a buy-out of £10 (GBP) (or equivalent currency value in country of engagement) per person in the Artiste's travelling party.

7) CANCELLATION

In the event of the performance or performances being cancelled by the promoter for any reason beyond the control of the Artiste, and within 48 hours of the proposed performance or performances, the full artiste's fee will be deemed payable. The Promoter further agrees that if the Artiste's performance is frustrated, shortened or brought to an end for any reason beyond the control of the Artiste it must be clearly understood that this in no way affects the salary payable to the Artiste. The Promoter should accordingly be insured against this eventuality, but if the Promoter fails to insure, it shall nevertheless pay the Artiste's fee in full.

8) DAMAGES & INSURANCE

The Abatimbo Drummers of Burundi carry Public Liability Insurance. The promoter shall have the necessary insurances in place in relation to the Venue in order to protect against the promoter's proven negligence

9) ACCESS AND RESTRICTIONS

There shall be adequate parking space reserved for the Artiste.

10) SECURITY

The Artists will be accompanied at all times by a member of the staff to changing rooms and performance areas etc.

11) LEGAL SETTLEMENT

This Contract shall be governed by the laws of England and the Courts of England shall have exclusive jurisdiction to settle any disputes which may arise out of or in connection with this Agreement. In relation to any legal action or proceedings to enforce this Contract or arising out of or in connection with this Contract each of the Parties irrevocably submit to the exclusive jurisdiction of the English courts.

We the undersigned have read and acknowledged all clauses set in this AGREEMENT and will ensure that they will be adhered to in strictest detail. We understand that this contract will only be valid when signed by ourselves un-amended. If amended, each amendment must be initialled by both parties.
